## IMMUNE CELL FUNCTION ASSAY (cont.)

### Description:

Monitoring lifelong immunosuppression is necessary to ensure long-term viability of solid organ transplantation or hematopoietic cell transplant (HCT) without incurring increased risk of infection. Immunosuppression monitoring endeavors to balance the risks of rejection and infection. This is currently determined by clinical toxicity testing (e.g., leukopenia, renal failure) and therapeutic drug monitoring when available. However, pharmacokinetics can differ among individuals due to clinical factors and possibly not reflect drug concentration in relevant tissues. Additionally, immunosuppression levels can vary from person to person. Individual immune profiles, such as immune cell function assays, have been investigated as methods that may support clinical decision making and help manage the risk of rejection and infection in immunosuppressed individuals.

ImmuKnow® is an immune cell function assay that involves detection of cell mediated immune response in individuals undergoing immunosuppressive therapy for organ transplant. It shows variable associations with infection and rejection depending on the type of transplant and the context of the study. Pleximmune™ measures CD154 expression on T-cytotoxic memory cells in an individual's peripheral blood lymphocytes. CD154 is a marker of inflammatory response.

### Criteria:

- Use of the immune cell function assay for all indications is considered ***experimental or investigational*** based upon:
  1. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
  2. Insufficient evidence to support improvement of the net health outcome, and
  3. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives.

These indications include, *but are not limited to:*

- Monitoring and predicting immune function after solid organ transplantation
- Monitoring and predicting immune function after hematopoietic stem cell transplantation

FDA 510K Summary for ImmuKnow:

- FDA-approved indication: For the detection of cell-mediated immunity in an immunosuppressed population.

FDA Humanitarian Device Exemption for Pleximmune:

- The HDE allows Plexision to market the above device to be used in the pre-transplantation, early and late post-transplantation period in pediatric liver and small bowel transplant patients for the purpose of predicting the risk of transplant rejection within 60 days after transplantation or 60 days after sampling.
