ST2 ASSAY FOR CHRONIC HEART FAILURE (cont.)

Description:

Heart failure (HF) refers to a complex clinical syndrome that is characterized by abnormal mechanical function of the heart, leading to inadequate perfusion of vital organs. Clinical assessment and noninvasive imaging methods can be limited in accurately diagnosing individuals with HF because symptoms and signs can be poorly correlated with objective methods of assessing cardiac dysfunction.

The protein biomarker ST2 (suppression of tumorigenicity-2) has been investigated as a potential aid to predict prognosis and manage therapy of chronic HF. This protein is a member of the interleukin-1 (IL-1) receptor family. Blood concentrations of ST2 may correlate with adverse cardiac structure and functional changes consistent with remodeling in individuals with HF, including abnormalities in filling pressures, chamber size and systolic and diastolic function.

The Presage® ST2 Assay kit is an in vitro diagnostic device that quantitatively measures ST2 in serum or plasma by enzyme-linked immunosorbant assay (ELISA) in microtiter plate format. The Presage ST2 Assay in conjunction with clinical evaluation has been investigated in assessing the prognosis of individuals diagnosed with chronic heart failure.

Criteria:

For laboratory testing for galectin-3, see BCBSAZ Medical Coverage Guideline #O695, “Laboratory Testing for Galectin-3”.

➤ Presage ST2 Assay for the following indications is considered ***experimental or investigational*** based upon:

1. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
2. Insufficient evidence to support improvement of the net health outcome, and
3. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives, and
4. Insufficient evidence to support improvement outside the investigational setting.

These indications include, *but are not limited to*:

- Evaluate the prognosis of individuals diagnosed with chronic heart failure
- Guide management (pharmacological, device-based, exercise, etc.) of individuals diagnosed with chronic heart failure
- Post cardiac transplantation period, including but not limited to predicting diagnosis and predicting acute cellular rejection
