## NON-CONTACT ULTRASOUND FOR THE TREATMENT OF WOUNDS (cont.)

### Description:

It has been proposed that low frequency ultrasound may improve wound healing via the production, vibration, and movement of micron-sized bubbles in the coupling medium and tissue. A non-contact low-intensity ultrasound (US) device has been developed that does not require use of a coupling gel or other direct contact. The MIST Therapy™ System delivers a saline mist to the wound with low-frequency US (40 KHz); it includes a generator, a transducer, and a disposable applicator for discharge of prepackaged saline. A second device, the Qoustic Wound Therapy System™, also uses sterile saline to deliver ultrasound energy (35 KHz) for wound debridement and irrigation.

### Criteria:

- Non-contact ultrasound for the treatment of wounds with the following devices is considered **experimental or investigational** based upon:
1. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
  2. Insufficient evidence to support improvement of the net health outcome, and
  3. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives, and
  4. Insufficient evidence to support improvement outside the investigational setting.

Devices include, *but are not limited to*:

- MIST Therapy System
- Qoustic Wound Therapy System
