HEART/LUNG TRANSPLANT (cont.)

Description:

A combined heart/lung transplant is a surgical procedure in which one or both lungs and heart from a single cadaver donor are placed in the body of a recipient for end-stage cardiac and pulmonary disease.

Potential contraindications subject to the judgment of the transplant center:

- Known current malignancy, including metastatic cancer
- Recent malignancy with high risk of recurrence
- Untreated systemic infection making immunosuppression unsafe, including chronic infection
- Other irreversible end-stage disease not attributed to heart or lung disease
- History of cancer with a moderate risk of recurrence
- Systemic disease that could be exacerbated by immunosuppression
- Psychosocial conditions or chemical dependency affecting ability to adhere to therapy

Criteria:

Heart/lung transplants will be reviewed by the medical director(s) and/or clinical advisor(s).

Pretransplantation Evaluation:

- Psychosocial screening for an individual that does not have fulminant cardiac failure¹ with documentation of **ALL** of the following:
 1. Drug/alcohol screen with documentation of **ONE** of the following:
 - No drug/alcohol abuse by history
 - Drug and alcohol free for a period greater than or equal to 6 months
 2. Behavioral health disorder screening with documentation of **ONE** of the following:
 - No behavioral health disorder by history
 - Behavioral health disorder by history with documentation of **BOTH** of the following:
 - No severe psychosis/personality disorder
 - Mood/anxiety disorder excluded/treated
 3. Individual understands surgical risk and post procedure compliance and follow-up
 4. Adequate social/family support

Criteria: (cont.)

- Heart/lung transplantation is considered **medically necessary** for an individual with **ALL** of the following:
 1. Pretransplantation evaluation criteria above is met
 2. **ANY** of the following end-stage cardiac and pulmonary disease diagnoses:
 - Cystic fibrosis with severe heart failure
 - Chronic obstructive pulmonary disease (COPD) with heart failure
 - Eisenmenger complex with irreversible pulmonary hypertension and heart failure
 - Emphysema with severe heart failure
 - Irreversible primary pulmonary hypertension with heart failure
 - Non-specific severe pulmonary fibrosis with severe heart failure
 - Pulmonary fibrosis with uncontrollable pulmonary hypertension or heart failure
 - Heart/lung retransplantation after a failed primary heart/lung transplant is considered **medically necessary** for individuals who meet above criteria for heart/lung transplantation.
 - Heart/lung transplantation for all other indications not previously listed or if above criteria not met is considered **experimental or investigational** based upon:
 1. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
 2. Insufficient evidence to support improvement of the net health outcome, and
 3. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives.
- ¹ Individuals with fulminant cardiac failure do not need to meet psychosocial screening criteria.
