Description:

Transcatheter pulmonary valve implantation (TPVI) is an alternative to open pulmonary valve replacement for individuals experiencing right ventricular outflow tract (RVOT) dysfunction following surgical repair of congenital heart disease. RVOT dysfunction includes pulmonary stenosis and regurgitation.

Description: (cont.)

The Melody® Transcatheter Pulmonary Valve and the Ensemble® Transcatheter Valve Delivery System are U.S. Food and Drug Administration (FDA) approved. The devices were originally FDA approved under the Humanitarian Device Exemption (HDE) Program. In 2015, approval of the Melody device was amended to a premarket approval (PMA).

The Edwards Sapien XT™ Transcatheter Heart Valve (Pulmonic) is also FDA approved.

Criteria:

- Transcatheter pulmonary valve implantation (TPVI) for individuals with congenital heart disease and current right ventricular outflow tract (RVOT) obstruction or regurgitation is considered **medically necessary** with documentation of **ANY** of the following:
 1. Individuals with right ventricle-to-pulmonary artery conduit with or without bioprosthetic valve with at least moderate pulmonic regurgitation
 2. Individuals with native or patched RVOT with at least moderate pulmonic regurgitation
 3. Individuals with right ventricle-to-pulmonary artery conduit with or without bioprosthetic valve with pulmonic stenosis (mean RVOT gradient at least 35 mm Hg)
 4. Individuals with native or patched RVOT with pulmonic stenosis (mean RVOT gradient at least 35 mm Hg)
- Transcatheter pulmonary valve implantation (TPVI) for all other indications or if above criteria not met is considered **experimental or investigational** based upon:
 1. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
 2. Insufficient evidence to support improvement of the net health outcome, and
 3. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives, and
 4. Insufficient evidence to support improvement outside the investigational setting.
