CRYOSURGICAL ABLATION OF PRIMARY OR METASTATIC LIVER TUMORS (cont.)

Description:

Cryosurgical ablation (CSA) involves the freezing of target tissues, most often by inserting into the tumor a probe through which coolant is circulated. Cryosurgical ablation can be performed as an open surgical technique or percutaneously or laparoscopically, typically with ultrasound (US) guidance. It has been investigated in the treatment of primary or metastatic liver tumors.

Criteria:

All requests for treatment of hepatocellular carcinoma will be reviewed by the medical director(s) and/or clinical advisor(s).

- Cryosurgical ablation for the treatment of primary or metastatic liver tumors is considered ***experimental or investigational*** based upon insufficient scientific evidence to permit conclusions concerning the effect on health outcomes.
