## EYELID THERMAL PULSATION FOR THE TREATMENT OF DRY EYE SYNDROME (cont.)

### Description:

Meibomian glands are located on the eyelids and secrete a substance that keeps the eyelids from sticking together. They may also be referred to as tarsal glands. Meibomian gland dysfunction (MGD) is recognized as the major cause of dry eye syndrome. Eyelid thermal pulsation devices apply heat to the palpebral surfaces of the upper and lower eyelids directly over the meibomian glands, while simultaneously applying graded pulsatile pressure to the outer eyelid surfaces, thereby expressing the meibomian glands. Automated evacuation of meibomian glands, using an eyelid thermal pulsation device, has been investigated as a treatment for adults with chronic cystic conditions of the eyelids, including, *but not limited to*, chalazia and MGD, also known as evaporative dry eye or lipid deficiency dry eye. Devices include the LipiFlow® Thermal Pulsation System.

### Criteria:

- Eyelid thermal pulsation therapy to treat dry eye syndrome is considered **experimental or investigational** based upon:
  1. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
  2. Insufficient evidence to support improvement of the net health outcome, and
  3. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives.
