OPTICAL COHERENCE TOMOGRAPHY (OCT) OF THE ANTERIOR EYE SEGMENT (cont.)

Description:

Optical coherence tomography (OCT) is a high resolution method of imaging the ocular structures. OCT for the anterior eye segment has been investigated as a non-invasive diagnostic and screening tool for a number of applications to determine whether there is a narrowing of the anterior chamber angle. These applications include:

- To determine whether there is a narrowing of the anterior chamber angle, which could lead to angle closure glaucoma
- Presurgical and post-surgical evaluation of anterior chamber procedures. This could include assessment of corneal thickness and opacity, calculation of intraocular lens power, guiding surgery, imaging intracorneal ring segments, and assessing complications following surgical procedures such as blockage of glaucoma tubes or detachment of Descemet membrane following endothelial keratoplasty.
- To image pathologic processes such as dry eye syndrome, tumors, noninfectious uveitis and infections

Criteria:

For optical coherence tomography (OCT) of the posterior eye segment criteria, see BCBSAZ Medical Coverage Guideline #O697, "Ophthalmologic Techniques That Evaluate the Posterior Segment for Glaucoma".

- Scanning computerized ophthalmic imaging (e.g. OCT) of the anterior segment of the eye is considered **experimental or investigational** based upon:
 1. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
 2. Insufficient evidence to support improvement of the net health outcome, and
 3. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives.
