VISCOCANALOSTOMY AND CANALOPLASTY (cont.)

Description:

Glaucoma results from increased intraocular pressure (IOP). When pharmacological intervention is not sufficient to decrease IOP, surgery may be required. The conventional trabeculectomy is a filtering procedure that creates an opening for aqueous outflow to drain into the subconjunctival space, but commonly results in filtering “blebs” on the eye and other complications.

Alternative nonpenetrating methods being evaluated to treat glaucoma include viscocanalostomy and canaloplasty. Viscocanalostomy unroofs and dilates the Schlemm canal without penetrating the trabecular meshwork or anterior chamber. A high-viscosity viscoelastic solution is used to open the canal and create a passage from the canal to a scleral reservoir. Viscocanalostomy has been investigated for lowering IOP while avoiding bleb-related complications.

Canaloplasty involves dilation and tension of the Schlemm canal with a suture loop between the inner wall of the canal and the trabecular meshwork. The iTrack™ illuminated microcatheter has been FDA approved for fluid infusion and aspiration, as well as, illumination during surgery.

Criteria:

- Canaloplasty as a method to reduce intraocular pressure (IOP) for the treatment of chronic primary open-angle glaucoma is considered **medically necessary** with documentation of **ALL** of the following:
 1. Medical treatment has failed to adequately control IOP
 2. Individual is not a candidate for any other IOP-lowering procedure (e.g., trabeculectomy, glaucoma drainage implant) due to high risk complications
- Canaloplasty for all other indications not previously listed or if above criteria not met is considered **experimental or investigational** based upon:
 1. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
 2. Insufficient evidence to support improvement of the net health outcome, and
 3. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives, and
 4. Insufficient evidence to support improvement outside the investigational setting.

These indications include, *but are not limited to:*

- Angle-closure glaucoma
- Viscocanalostomy is considered **not medically necessary** based upon insufficient evidence to support improvement of the net health outcome.
