Description:

Drug-eluting punctum plugs can be placed within the canaliculus to deliver precise drug doses for a predetermined period of time. These bioabsorbable plugs have been investigated for use after cataract surgery and for the treatment of conjunctivitis or glaucoma.

Drug-eluting ocular inserts rest under the eyelids and are formulated with a drug which releases onto the eyes to reduce intraocular pressure. These inserts replace eye drops and provide sustained therapy for eye diseases including glaucoma, dry eye, and allergy

DRUG-ELUTING PUNCTUM PLUGS AND OCULAR INSERTS (cont.)

Criteria:

- Drug-eluting punctum plugs are considered **experimental or investigational** based upon:
1. Lack of final approval from the Food and Drug Administration, and
 2. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
 3. Insufficient evidence to support improvement of the net health outcome, and
 4. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives, and
 5. Insufficient evidence to support improvement outside the investigational setting.

Drug-eluting punctum plugs include, *but are not limited to*:

- Dexamethasone Punctum Plug (OTX-DP)
- Moxifloxacin Punctum Plug (OTX-MP)
- Travoprost Punctum Plug (OTX-TP)

- Drug-eluting ocular inserts are considered **experimental or investigational** based upon:

1. Lack of final approval from the Food and Drug Administration, and
2. Insufficient scientific evidence to permit conclusions concerning the effect on health outcomes, and
3. Insufficient evidence to support improvement of the net health outcome, and
4. Insufficient evidence to support improvement of the net health outcome as much as, or more than, established alternatives, and
5. Insufficient evidence to support improvement outside the investigational setting.
