## ROZLYTREK™ (entrectinib) oral capsule

---

### Criteria:

- **Criteria for initial therapy:** Rozlytrek (entrectinib) is considered *medically necessary* and will be approved when **ALL** of the following criteria are met:
1. Prescriber is a physician specializing in patient's diagnosis or is in consultation with an Oncologist
  2. Individual is 18 years of age or older
  3. A confirmed diagnosis of **ONE** of the following:
    - Adult patient, 18 years of age or older, with metastatic non-small cell lung cancer (NSCLC) whose tumors are *ROS1*-positive and have an ECOG performance status of  $\leq 2$
    - Adult and pediatric patients 12 years of age and older with solid tumors that have a neurotrophic tyrosine receptor kinase (*NTRK*) gene fusion without a known acquired resistance mutation, are metastatic or where surgical resection is likely to result in severe morbidity, and have progressed following treatment or have no satisfactory alternative therapy
    - Other request for a specific oncologic direct treatment use that is found and listed in the National Comprehensive Cancer Network (NCCN) Guidelines with Categories of Evidence and Consensus of 1 and 2A
  4. **ALL** of the following baseline tests have been completed before initiation of treatment with continued monitoring as clinically appropriate:
    - Assessment of left ventricular ejection fraction in an individual with heart failure symptoms or known risk factors
    - Electrocardiogram
    - Liver function tests
    - Electrolytes
    - Serum uric acid
    - Negative pregnancy test in a woman of child bearing potential
  5. Will not be used in individual with severe renal impairment (CrCl < 30 mL/min)
  6. Will not be used in individual with moderate (total bilirubin > 1.5-3x ULN) or severe (total bilirubin > 3x ULN) hepatic impairment

**Initial approval duration:** 6 months

- **Criteria for continuation of coverage (renewal request):** Rozlytrek (entrectinib) is considered *medically necessary* and will be approved when **ALL** of the following criteria are met:
1. Individual continues to be seen by a physician specializing in patient's diagnosis or is in consultation with an Oncologist

2. Individual's condition responded while on therapy
  - Response is defined as:
    - No evidence of disease progression
    - Documented evidence of efficacy, disease stability and/or improvement
3. Individual has been adherent with the medication
4. Individual has not developed any other significant level 4 adverse drug effects that may exclude continued use
  - Significant adverse effect such as:
    - Hepatic impairment
    - QTc prolongation
    - Torsades de pointes, polymorphic ventricular tachycardia, or signs and symptoms of serious arrhythmia
    - Heart failure
    - Intolerable central nervous system adverse effects such as mood disorders, dizziness, sleep disturbances, memory impairment, amnesia, hallucinations, and delirium
    - Toxicity that does not resolve within 4 weeks of dose reduction or recurrence of severe or life-threatening toxicity
    - Skeletal fractures
5. Will not be used in individual with severe renal impairment (CrCl < 30 mL/min)
6. Will not be used in individual with moderate (total bilirubin > 1.5-3x ULN) or severe (total bilirubin > 3x ULN) hepatic impairment
7. There are no significant interacting drugs

**Renewal duration:** 12 months

### **Description:**

Rozlytrek (entrectinib) is a kinase inhibitor indicated for the treatment of adult patients, 18 years of age or older, with metastatic non-small cell lung cancer (NSCLC) whose tumors are *ROS1*-positive; and for adult and pediatric patients 12 years of age and older with solid tumors that have a neurotrophic tyrosine receptor kinase (*NTRK*) gene fusion without a known acquired resistance mutation, are metastatic or where surgical resection is likely to result in severe morbidity, and have progressed following treatment or have no satisfactory alternative therapy. The *NTRK* gene fusion positive solid tumor indication is approved under accelerated approval based on tumor response rate and durability of response. Continued approval for this indication may be contingent upon verification and description of clinical benefit in the confirmatory trials.

Patients should be selected for the treatment of metastatic NSCLC based on the presence of *ROS1* rearrangement(s) in tumor specimens. In addition, patients should be selected for treatment of locally advanced

or metastatic solid tumors based on the presence of a *NTRK* gene fusion. However, an FDA-approved test for the for detection of *ROS1* rearrangement(s) in NSCLC and for detection of *NTRK* gene fusion in solid tumors are not available

Entrectinib inhibits tropomyosin receptor tyrosine kinases (TRK) TRKA, TRKB, and TRKC. TRKA, TRKB, and TRKC are encoded by neurotrophic receptor tyrosine kinase (NTRK) genes *NTRK1*, *NTRK2*, and *NTRK3*, respectively. Entrectinib also inhibits proto-oncogenic tyrosine-protein kinase ROS1 and anaplastic lymphoma kinase (ALK). M5 (the major active entrectinib metabolite) demonstrated similar activity (in vitro) against TRK, ROS1, and ALK. Fusion proteins that include TRK, ROS1, or ALK kinase domains act as oncogenic drivers to promote hyperactivation of downstream signaling pathways, resulting in unchecked cell proliferation.

### **Definitions:**

#### **Response Evaluation Criteria in Solid Tumors (RECIST):**

- Complete response – disappearance of all target lesions
- Partial response – 30% decrease in the sum of the longest diameter of target lesions
- Progressive disease – 20% increase in the sum of the longest diameter of target lesions or the appearance of one or more new lesions
- Stable disease – small changes that do not meet the above criteria of PR and PD

#### **Common Terminology Criteria for Adverse Events (CTCAE) Version 4.0:**

Grade 1	Mild; asymptomatic or mild symptoms; clinical or diagnostic observations only; intervention not indicated
Grade 2	Moderate; minimal, local or noninvasive intervention indicated; limiting age-appropriate instrumental ADL*
Grade 3	Severe or medically significant but not immediately life-threatening; hospitalization or prolongation of hospitalization indicated; disabling; limiting self-care ADL**
Grade 4	Life-threatening consequences; urgent intervention indicated
Grade 5	Death related to AE
