

# IMPORTANT CHANGE STARTING JANUARY 1, 2020

A change in federal law may affect your choice of Medicare Supplement plans. Starting January 1, 2020, Medicare Supplement plans will no longer cover the Part B deductible for people who are new to Medicare.

**Because of this change, Medicare Supplement Plans C and F will be available only to people who are eligible for Medicare before January 1, 2020.**

Rest assured that Blue Cross® Blue Shield® of Arizona will continue to offer many choices in Medicare Supplement plans. We can help you find one that's right for you, no matter what your needs might be.

## WHAT DOES THIS CHANGE MEAN FOR YOU?

- **If you will turn 65 and become eligible for Part A coverage before January 1, 2020**, you can purchase any of the following Medicare Supplement plans: Senior Security Plans A, C, D, F, G, or N, OR Senior Preferred Plans C, D, G, or N.
- **If you will be turning 65 on or after January 1, 2020**, your choices include Senior Security Plans A, D, G, or N, OR Senior Preferred Plans D, G, or N.\*

\*Senior Preferred plans are available only to residents of Maricopa, Pima, Apache, Cochise, Coconino, Mohave, Pinal, and Santa Cruz counties.
